#### ATTENDANCE AND PUNCTUALITY

11. If your child/ward is unwell, please ensure they receive prompt medical attention. A medical certificate or a letter from a parent/guardian is required to explain any absence from school. Please note that disciplinary measures may be taken in cases of wilful absenteeism or truancy.

#### COMMUNICATION PLATFORMS

12. Parents/Guardians will receive more updates on school programmes and activities in the letter to parents/guardians every term via **Parents Gateway**. The Parents Gateway (PG) Mobile App is an initiative by MOE to enable parents/guardians to interact with schools more conveniently on administrative and financial matters.

13. Parents/Guardians will also be able to use this app to stay updated on school programmes and submit online consent forms for their child's/ward's activities. **SingPass Registration and 2FA Setup are required for PG access.** All parents/ guardians are **strongly encouraged** to download and use the PG App as it will bring significant benefits for parents, guardians, teachers and the school. Parents can log on to <u>https://studentgpa.incomegroupins.com.sg</u> to submit an online claim through the e-claim portal.

#### Points to note:

- For both inpatient and outpatient including minor/day surgery claims, you are not required to submit the original tax invoice(s)/receipts(s). However, you <u>must keep</u> the original tax invoice(s)/receipt(s) for at least 6 months from claim submission date and it must be made readily available upon Insurer's request.
- 2. If you have utilised your Medisave/MediShield/Private Shield plan to pay for your child's surgical and hospitalisation fees, please kindly request for a **Letter of Settlement** from your insurer for submission together with the original tax invoice(s)/receipts(s).
- 3. Please ensure your email address, handphone number and bank account details in the e-claim portal are correct.
- 4. Please prepare your scanned receipts/reports for uploading before proceeding with a new eSubmission.

Scanned files must meet the following criteria: \*Acceptable file formats are pdf, jpg, jpeg and png \*Maximum allowable size for each attachment is up to 10MB.
